Sturgeon Bay, WI., March 6, 2024— The Women's Fund of Door County will present its 11th annual Tales of Our Lives Story Slam on Saturday, April 20. This year's event includes an exciting new collaboration with Northern Sky Theater, which will host the performance at its Gould Theater.

This year's storytellers include:

- Allison Haus: Haus will tell a story about unexpected events that completely changed the course of her life while working on her post-doctorate in France.
- Jewel Peterson Ouradnik: Peterson Ouradnik tells a story about growing up on her family's resort in Rowley's Bay, which she and her husband owned until the devastating fire in 2023. She recounts that harrowing day and the difficult decision to ultimately sell the resort.
- Mel Ripp: Taking the stage for the third time, Ripp shares a journal excerpt from when she was 22 years old and in graduate school.
- Georgina Saunderson Hatch: Saunderson Hatch's story begins when she was a young girl growing up in Jamaica and continues to present day as a mother with two children with special needs.

Storytelling begins at 7pm followed by a reception.

Tickets cost \$30 each and can be purchased directly from Northern Sky Theater's Box Office beginning March 15. The Women's Fund of Door County looks forward to an evening of inspiration and connection.
